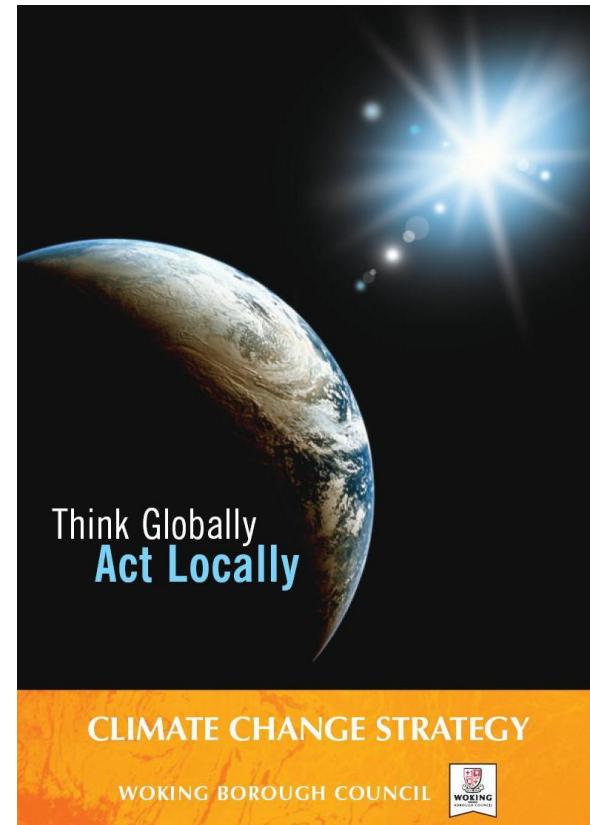

## Our Assets

- Carbon footprint assessment
- Midas House and Export House energy efficiency retrofit and connection to energy network
- £9.4 million Heat Networks Investment Project (HNIP)
- Domestic energy efficiency report to O&S November 2022

## Transport

- £166,000 government funding from OZEV awarded for electric vehicle (EV) points at Victoria Place development
- On-street electric vehicle charging pilot
- Levelling Up Active Travel bid submitted for Sheerwater/West Byfleet corridor
- Surrey EV Forum concession framework for chargepoint delivery
- Introduction of fees for EV charging agreed
- Secure cycle storage bid
